### PUBLIC PROCUREMENT RESEARCH GROUP SCHOOL OF LAW UNIVERSITY OF NOTTINGHAM

The Public Procurement Research Group, directed by Professor Sue Arrowsmith, is a major global centre of research in the field of public procurement. The Group would like to invite PhD students who are researching on issues related to public procurement law and regulation to the third public procurement PhD conference. This will be held at the School of Law, University of Nottingham, on 21-22 of June 2007.

The conference confirms the Group's interest in promoting the work of young scholars and researchers. The conference is aimed

at research students of all levels. It offers an opportunity to meet fellow scholars from all around the world who are engaged in related fields of research. The conference provides a forum in which people with different perspectives can discuss and learn from each other in an informal setting. We welcome papers not just from scholars in law but from those in any discipline (business, economics etc) whose research touches on issues affecting procurement regulation in a broad sense. Papers will be discussed by fellow students and input will also be offered by academic staff of the Public Procurement Research Group and other invited academics.

Papers may present the subject of the PhD as a whole, or specific aspects of it.
